Matters Arising:

President's Report:

Des reported on the year past:

In 2014 a whole new P&C were elected and we have consistently struggled for numbers as a result we don't do a lot of fund raising. We have had a number of members resign due to work and family commitments. Our biggest challenge is communications and we aim to improve that this year. We try to concentrate on 2 big functions for the year:

• Canteen:

In the past we also did some Bunning Sausage Sizzles but we have given those to the Band Sub Committee.

We try to allocate the funds raised where the maximum number of students will benefit from it. Generally the process that we follow is that the school will give us a list of projects they require funds for and then we will allocate the funds if we have them or alternatively try to raise the funds. We need members to come to the meetings to help us make decisions on the fund raising events and what we spend it on. Previous projects include:

- Projector and Screen for the gym
- 14 new computers for the computer room.

Currently we are working on the signs for the school and Justin will put together a list of other projects.

We also like to thank the staff for the support they give to the P&C and our children and to that end we hand out Easter Eggs and we have also catered a breakfast. Our next activity is the Open Day on the 7th of March.
